

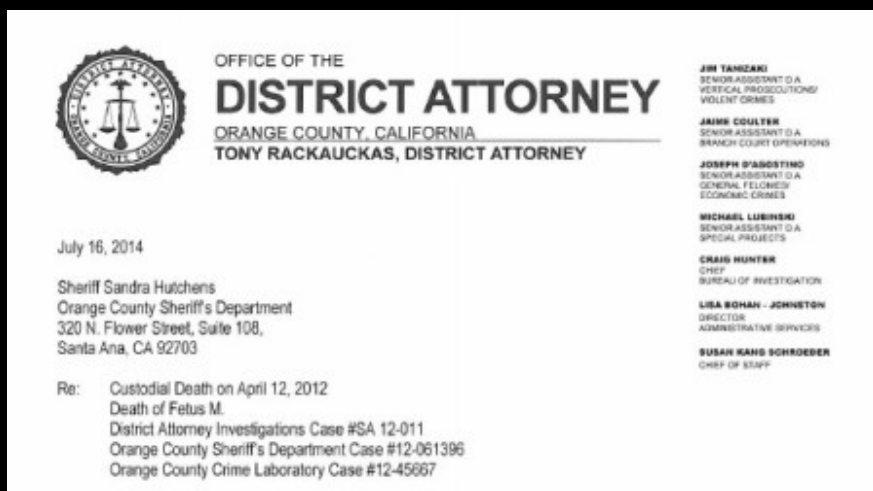

## Botched late term abortion by California clinic lands woman in hospital



The [OC Weekly](#) has reported that a woman who was under arrest was taken for late term abortion at the Family Planning Associates Medical Group (FPA) abortion clinic in Long Beach. Following her visit to FPA for the 20 week abortion the prisoner suffered an incomplete abortion and had to be hospitalized. The botched procedure was performed in 2012 but is only coming to light after the Orange County District Attorney's Office published their investigative report on the death of the fetus.

**From the story:**

*On March 13, 2012, Huntington Beach police arrested a woman identified in the report as "Lauren" for possession of a controlled substance. Because of a parole hold, authorities booked her into the Orange County Sheriff's Department (OCSD) Women's Main Jail. Lauren told staff there that she was 16 weeks pregnant and that both she and her boyfriend had agreed on aborting it when the relationship fizzled.*

*Having been unable to do so before she landed in custody, Lauren requested an abortion in mid-March. By the time the process began on April 4, 2012, at the **Family Planning Associates Medical Group in Long Beach**, an ultrasound determined her **to be 20 weeks pregnant**, requiring a three-day abortion. On April 11, Lauren returned to jail after the process began.*

*Around 1 a.m. the next day, Lauren complained of cramping; she sat on the can, believing she needed to relieve herself, when her pushing caused the unresponsive fetus to drop into the toilet while still attached via its umbilical cord. **Authorities transferred Lauren and "Fetus M." to Saint Joseph Hospital in Orange. Doctors concluded Lauren suffered an incomplete abortion and that the fetus was stillborn.***

*Everything about the procedure complied with the Reproductive Privacy Act and federal law. OCDA investigators saw no reason to file charges against anyone involved.*

Here is a copy of part of the **investigative report** detailing the condition of the unborn child:

#### DR. B.K. EXAMINATION AND DIAGNOSIS AT ST. JOSEPH HOSPITAL

Upon arrival at the hospital, Lauren was transferred to the second floor Labor & Delivery. Doctor B.K. examined Lauren at approximately 3:45 a.m. Dr. B.K.'s preoperative diagnosis was that she had suffered an incomplete abortion at 19 weeks with the fetus hanging from the cord attached to the placenta, as well as partial retention of the placenta. Dr. B.K. did not see any sign of trauma to Fetus M. and there was no sign of life. According to Dr. B.K., Fetus M. would not have survived outside the womb, as its lungs had not fully developed. Dr. B.K. severed the umbilical cord at approximately 3:48 a.m.

After Dr. B.K. severed the umbilical cord, Fetus M. was placed in a white plastic container inside a red plastic biohazard bag that remained in LDR #19 and was retained for examination by the Orange County Sheriff Coroner.

According to St. Joseph Hospital medical records, Fetus M. was male; the gestational age was approximately 20 weeks; length was 8.5 inches and weight was 270 grams, and the Apgar score was zero in all five categories.

The Apgar score quickly evaluates a newborn's physical condition and well being, and is usually given twice; once at one minute after birth, and again at five minutes after birth. The following five factors are used to evaluate the newborn's condition and each factor is scored on a scale from zero to two, with a score of two being the best score:

- Heart rate
- Respiration effort
- Muscle tone
- Reflex
- Skin coloration

According to St. Joseph Hospital's delivery summary, the Apgar score for Fetus M. was zero at one minute, and zero at five minutes. At both one and five minutes, Fetus M. presented an absent heart rate, an absent respiratory effort, flaccid muscle tone, and no response to reflex and was blue in color.

At approximately 6:30 a.m., Dr. B.K. performed a Dilatation & Curettage (D&C) on Lauren. During the D&C, the placenta was delivered, and six laminarias (dilators) were removed. Lauren tolerated the procedure well and suffered no complications.

#### ORANGE COUNTY CORONER INVESTIGATION AND ANALYSIS

##### FETUS M. EXAMINATION

At approximately 5:29 a.m. on April 12, 2012, an Orange County Coroner Investigator arrived at St. Joseph Hospital LDR #19. A second Orange County Coroner investigator arrived shortly thereafter. At approximately 5:52 a.m., Deputy Swain relinquished care and custody of Fetus M. to the two coroner investigators when Lauren was transferred to the Operating Room for the D&C procedure.

At approximately 6:05 a.m., the two Orange County Coroner Investigators performed a preliminary examination of Fetus M. and made the following observations:

- Fetus M. was inside a white plastic container and wrapped in a white towel.
- Fetus M.'s face and head were partially covered by the amniotic sac.
- A beige plastic clamp was affixed to Fetus M.'s umbilical cord.
- The placenta was photographed while inside a hospital container, but not retained.

Sadly, the abortion was ruled legal and in addition to the taxpayers funding the abortion and subsequent medical cost the baby's death will not be prosecuted.

**LAUREN'S ABORTION COMPLIED WITH THE REPRODUCTIVE PRIVACY ACT**

FPA determined that Lauren was eligible for an abortion because she was in the early stages of her pregnancy and her unborn fetus was not viable at the time FPA began the three-step abortion process. As indicated above, Dr. B.K. opined that Lauren had suffered an "incomplete abortion" and deemed Fetus M. a "stillbirth." Fetus M. was beyond the embryonic stage, as major structures had been outlined. Dr. B.K. estimated Fetus M.'s gestational age at approximately 19 or 20 weeks. Dr. Cohen corroborated that opinion, but estimated Fetus M.'s gestation age at approximately 19 or 20 weeks. Nevertheless, Fetus M. was not viable because according to Dr. B.K., Fetus M.'s lungs had not fully developed and would not have survived birth.


Therefore, the two doctors' opinions about Fetus M.'s gestational age confirm that the fetus was not "viable" and that the abortive procedure complied with RPA and federal law.

**CONCLUSION**

Based on all the evidence provided to and reviewed by the OCDA and pursuant to the applicable legal principles, there is no evidence to support a finding of criminal culpability on the part of any OCSD personnel or any individual under the supervision of OCSD. The evidence clearly shows that Fetus M.'s demise was the result of being "stillborn" due to an incomplete abortive procedure, lawfully requested by the fetus' mother, and that the abortive procedure complied with RPA and federal law and would fall under the exception to murder under Penal Code section 187(b).

Accordingly, the OCDA is closing its inquiry into this incident.

On Feb 4,2013, an ambulance arrived again at the Family Planning Associates abortion clinic of Bakersfield California. Pro-life sidewalk counselor, Terri Palmquist, who was at the clinic reports that Vernon Wagner the abortionist for Family Planning Associates in Bakersfield, CA. has "botched" at least three abortions in five months:



Here is the last report Saynsumthn did about this clinic:

Terry Palmquist a pro-lifer, who counsels outside the clinic posted this comment on her facebook page: ***"Minutes ago a Hispanic woman being transported from abortion chamber...pray for her, repentance and healing!"***

Terry also posted this:

*"Police on way to FPA abortion chamber...As abortionist was leaving, I said, "so did you botch another abortion along with killing all these babies?" He started swearing and screaming at me as he quickly approached me, "You don't know what the ..... you are talking about, b.....!"*





*I replied, "I know you are killing babies and have botched abortions!" [Vernon] Wagner, still approaching me as I stayed on the public sidewalk yells, get the f... out of my face!" He jumps down from parking lot and I thought he was coming to punch me, but he went to our crosses and started pitching them in the street! All the while screaming swear words!"*

That was not the first time a woman at the abortion clinic was at risk. In August of 2012, [LifeSavers Ministries](#) witnessed another ambulance arriving, here is their account:



An **ambulance** arrived Monday morning at the FPA abortion center in Bakersfield, as abortionist **Vernon Wagner** continued aborting babies inside. After a few minutes, the door to the abortion room opened, and a young black woman was taken out on a

*stretcher. The ambulance transported the woman to the Kern Medical Center emergency room. No further information about the woman's condition is available at this time.*

*The presence of the ambulance was a somber reminder of the dangers of "legal" abortion to women. Just a few weeks ago, Tonya Reaves bled to **death** after her baby was aborted in a Chicago Planned Parenthood.*

According to [40daysfor life](#): Wagner is not only responsible for the deaths of thousands of babies; he has also been sued for the death of Tami Suematsu. Her family accused Wagner of gross negligence for finishing his other abortions while she lay dying. [Life Dynamics](#) describes her **death** this way: Tami, who had a history of asthma, underwent an abortion at Riverside Family Planning Center on August 19, 1988 in

Riverside, California. After the surgery, she went into an asthma attack that led to respiratory failure, which resulted in cardiac arrest. She was transported to a local hospital and died shortly after arriving. She was 19 years old. (Riverside County (CA) Death Certificate No. 38833005990; Riverside County (CA) Autopsy File No. 64442; State of California Certificate of Death # 149559)

According to [RealChoice Blog](#), Family Planning Assoc, the abortion clinic chain mentioned above has played a role in the **deaths** of Denise Holmes, Mary Pena, Josefina Garcia, Lanice Dorsey, Joyce Ortenzio, Tami Suematsu, Christina Mora, Susan Levy, Patricia Chacon, Kimberly Neil, and Deanna Bell. FPA is a member of the [National Abortion Federation](#), an organization that ostensibly ensures that abortions are done safely.

### About Us

#### Pioneers in Family Planning

Family Planning Associates Medical Group (FPA) was founded in 1969, soon after abortion became legal in California. At that time it was called the Avalon-Glaussen Medical Group. All of the pregnancy terminations and other medical services were performed at Avalon Memorial Hospital in Los Angeles.

In many states, abortion was legal only for cases in which continuance of the pregnancy would be life threatening. California law was relatively liberal and many women came from Arizona, Colorado, Texas, and other states to receive legal abortions.

FPA's two physician founders, Dr. Edward C. Allred and Dr. Kenneth L. Wright, began immediately to concentrate on developing simpler and less expensive abortion procedures. In these early years, Dr. Wright pioneered the use of saline amniocentesis, a technique for terminating pregnancy safely in the second trimester.

Family Planning Assoc Founder, Abortion doctor Edward C. Allred had troubling attitudes toward African Americans. Allred once publicly stated, "When a sullen black woman of 17 or 18 can decide to have a baby and get welfare and food stamps and become a burden to all of us, it's time to stop..."

In 1995, the abortion clinic Allred ran would be accused of racism in the abortion-related death of a 24 year-old African American woman. It was in January of 1995, that 24 year-old African American TaTanisha Wesson went to the Family Planning Associates abortion clinic in Los Angeles, for an abortion and never came home. Her friend saw an ambulance arrive at the clinic that morning while sitting in the waiting room during the procedure.



She called TaTanisha's parents who rushed to the ER and found their beloved daughter in a coma. TaTanisha died in the hospital on February 1, 1995, leaving behind her 5 year old born son. An attorney for the family told the press that the abortion clinic gave TaTanisha too much anesthesia, that clinic staff was not present when she began to vomit, and that the abortion clinic delayed calling 911 for approx. 25 critical minutes. Her parents accused the abortionist of racism in their daughter's death.

TaTanisha is one of many women who believed the lie that legal abortion made a "safe" abortion.
