

Out of Town Program

Choices Women's Medical Center is taking a proactive stand to assist women who live in states that have abortion restrictions.

When our doors opened in 1971, our very first patient was from New Jersey, one of the states that did not allow abortion services at that time. Abortions are more widely available today, but many states still have restrictions that make them difficult to obtain, or don't have many abortion clinics available.

We help women navigate this obstacle by providing resources and assistance so they can access the care they need at our women's health clinic.

The out of town patient is assigned a special counselor at **Choices**, who will assist the patient throughout the process of making an appointment. 

Indictment charges abortion doctor, office manager..., posted with vodpod

Abortion doctor accused of Medicaid fraud

ATLANTA — 12/19/2011

A metro-area abortion doctor and his office manager are under arrest, accused of taking hundreds of thousands of dollars in fraudulent Medicaid



payments.

A spokesperson for Georgia's Attorney General says **Dr. Tyrone Malloy** and office manager **CathyAnn Warner took more than \$380,000 in payments for ultrasounds that were never done, and elective abortions that were prohibited from use of Medicaid funds.** The **Attorney General's** spokesman says that is only allowed when the mother's life is in danger, or in cases of rape or incest.

Malloy owns and operates the **Old National Gynecology** office in College Park, but received the Medicaid payments at his DeKalb County office on Rainbow Drive. A tip from Georgia's Department of Community Health, which oversees the Medicaid program, launched the investigation.

Channel 2 investigative reporter Jodie Fleischer knocked on the abortion clinic's locked doors on Monday. No one answered, but the camera captured people peering through the office blinds several times. About an hour later, a string of cars, presumed to be driven by employees, abruptly left, stopping briefly to lock the gate behind them.

A DeKalb County grand jury indicted Malloy and Warner for two counts each of Medicaid Fraud. The charges carry up to ten years in prison and a \$10,000 fine.


Malloy was arrested and bonded out of jail last week. Deputies picked up Warner late Monday afternoon.

The clinic's website says its physicians are well versed in the changing laws of abortion medicine. They also provide a discount for Medicaid patients.

By phone, a receptionist at Dr. Malloy's DeKalb office told Fleischer to leave a message; that he was in with a patient. He did not return the call. The office manager, when reached by phone, hung up on Fleischer.

The Georgia Supreme Court heard an appeal of a pre-trial ruling involving an abortionist accused of illegally using **Medicaid funds to perform services associated with abortions. **Tyrone Malloy** who was involved in the 2009 abortion related death of a 23 year-old patient, was indicted in 2011 by a Georgia DeKalb County grand**



jury for two counts of Medicaid fraud. The indictment alleges that from 2007-2010, Malloy accepted \$131,615 in Medicaid payments to which he wasn't entitled "because such services were associated with the performance of elective abortions." The second count alleges that in the same period, Malloy then fraudulently accepted \$255,024 in Medicaid payments for "detailed" ultrasounds which had not been performed. If convicted, Malloy could be sentenced to a \$10,000 fine or up to 10 years in prison.

On March 21, 2008, 23 year old Sherika Mayo, went to **Summit Medical Associates** in Atlanta, Georgia for the elective abortion of her 25 week unborn child. After the abortion, while in the recovery room, the woman went into cardiac arrest and was transferred to Atlanta Medical Center where she underwent a hysterectomy and bowel repair. Medical records indicate that vigorous blood product replacement was undertaken, but the women coded in the I.C.U. where she died. **The Georgia State Medical Board** reviewed the case and determined that the abortionist, Tyrone Malloy, "failed to conform to minimal standards of acceptable and prevailing medical practice." His license was reprimanded and while he was ordered to pay a \$10,000.00 fine, he was allowed to continue practicing and performing abortions.

FINDINGS OF FACT

1.

Respondent is licensed to practice medicine in the State of Georgia and was licensed
as such at all times relevant to the matters stated herein.

2.

Medical records show that on or about March 21, 2008 23 year old patient S.M.
presented at Respondent's office, Summit Medical Associates, Atlanta, GA, for an elective
termination of her 25 week pregnancy. Medical records show that patient S.M. had anemia
and sickle cell trait. Medical records further show that prior to the procedure patient S.M.'s
Hgb level was 7.3 gms and repeat Hgb was 7.1 gms.



Medical records show that after the procedure, while in the recovery room at Respondent's outpatient facility, patient S.M. went into cardiac arrest and was transferred to

Atlanta Medical Center. Medical records show that CPR continued in the emergency room and gynecology was consulted because the patient had vaginal bleeding and distended abdomen. Medical records further show that patient S.M. was taken to the operating room for exploration for possible intraabdominal hemorrhage secondary to perforation. Medical records show that exploration revealed a suture on the posterior cervix. Respondent contends neither intraabdominal hemorrhage nor uterine perforation was discovered during exploratory surgery and that during this exploratory procedure, S.M. suffered an iatrogenic bowel injury.

4.

Medical records show a hysterectomy and a bowel repair were performed during the surgery at Atlanta Medical Center, and that postoperatively the patient manifested signs and symptoms of DIC. Medical records indicate vigorous blood product replacement was undertaken but patient S.M. coded in the ICU and died.



He obtained his MD from the Johns Hopkins School of Medicine and interned and performed his residency in obstetrics and gynecology at Walter Reed Army Medical Center. Following several years of medical practice, Dr. Malloy returned to school, this time earning a JD from the Georgia State University College of Law.

Prior to undertaking his multitude of current roles, Dr. Tyrone Malloy served as Chief of Medical Staff at DeKalb Medical Center, Organizer and Clinical Trial Director for Medical Network Research, and Staff Physician at Moncrief Army Hospital. He has sat on the Board of Directors of Omni Global, Inc., and Progressive Medical Services of Georgia. In his capacity as attorney, he acted as CEO and President of Atlanta Legal Medical Consultants, Inc.

[Dr. Malloy](#) has acted as Principal Investigator in more than 70 research trials and has published numerous papers. He is a member of the American Fertility Society; the American Society of Law, Medicine, and Ethics; Planned Parenthood Federation of America; the Society of Clinical Research Associates; the National Medical Association; and the American Association of Clinical Research Professionals.
