Because I can leave my judgment and the noise of the day at the door Because it's part of taking care of women and not everyone thinks so Because it's the right thing to do and not everyone thinks so

It is an absolute honor and privilege to care for a woman during a time in her life when she is feeling most vulnerable, whether it be during the birth of her child or it be for her abortion. As an OB/GYN, I provide abortions because I believe comprehensive reproductive health care is a right and should be easily accessible, without judgment. It is incredibly rewarding to provide a service that helps a woman build her family in the way that she feels is best.

I provide abortions because I am a family physician. Why wouldn't I? How could I not? When patients are facing an unintended pregnancy, I can't imagine telling them to go elsewhere if they make the deeply personal decision to terminate. We discuss their options, and I tell them I'll be their doctor no matter what they decide to do. I offer them the most up-to-date, evidence-based information without judgment, just as I do when they come to me for their sore throat, their asthma, or their child's vaccines. Providing abortions is just another part of providing care for my patients as a family doctor.

As an abortion provider in an intensely conservative state, I often get asked why I do the work I do. Why deal with the fallout, the safety concerns, the protestors, the snubs from colleagues and nurses in the hospital who know about my "other" job?
