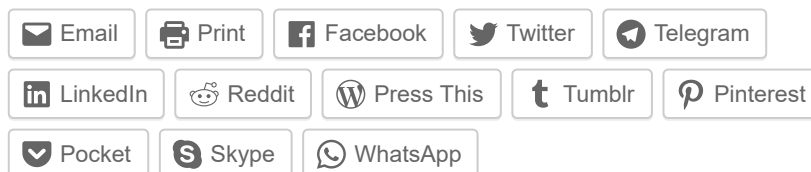
Bail set at \$900,000 for abortion doctor charged in pill mill sweep

In Florida, [A West Palm Beach judge has ordered Dr. Zvi Harry Perper to give up his passport and his right to practice medicine. Perper is yet another abortionist who has worked at one of James Pendergraft's chain of five late term abortion clinics in Florida. Abortionist Perper was arrested and charged with racketeering and drug trafficking in a raid on Delray Beach Pain Management a clinic started by Kent Murry, a convicted drug smuggler and career criminal. Authorities say Perper, ranked 22nd in the nation among medical practitioners in ordering oxycodone. Perper was also on duty at the EPOC abortion clinic in Orlando in 1995 when **Baby Rowan** was born alive and left to die, and has been disciplined for performing a botched abortion in 2003. He faces 18 counts, including racketeering, trafficking in oxycodone and conspiracy to traffic in oxycodone.](#)
