**Dr. David H Orenstein** made \$153,913 in **2010** working for Planned Parenthood Arizona

CEO Bryan Howard took home \$202,402 that same year

**Dr. Deshawn Taylor** VP Medical Services raked in \$204,943

Patricia Caldwell COO made \$100,282

Rachel Chanes made \$90,447

CFO Deborah Budnick made \$109,746 in **2009**

**2008** CFO David Richardson took home \$ 75,457

Under the Name Planned Parenthood of Central and Northern Arizona , according to **2005** 990's

**Physician Celeste S. Mendez MD** made \$\$89,624

And Physicians under **Penguin Services Trust** made \$231,080 while Physicians under **Three Dog Surgical** made \$165,705

Pat Levin , VP Of medical Services Made \$104,103

In **2004** Beth Meyer made \$88,263 as VP of External Affairs

Planned Parenthood received **\$349.6 million in tax dollars in the fiscal year ending on June 30, 2008**, and \$363.2 MILLION Dollars on **Government Grants ( Tax Dollars) in 2009**– that is ONE MILLION DOLLARS PER DAY of taxpayer money !!!



Cecile Richards; Planned Parenthood President

Planned Parenthood then took those hard earned dollars away from poor and middle

class hard working people and it paid its president, **Cecile Richards, \$385,163, plus another \$11,876 in benefits** and deferred compensation. ( [View 2008 990 here](#) )

The \$385,163 in pay Planned Parenthood President Richards received in the organization's fiscal year ending June 30, 2008 was recorded in the group's publicly available Internal Revenue Service Form 990 filed for that year.

Richards also received \$346,285 in total compensation from Planned Parenthood and \$38,476 in total compensation from related groups in the organization's fiscal year that ended on June 30, 2009, according to the organization's Form 990 for that year. In a **2010** PPFA 990, Cecile Richards reported earning \$319,245 from PPFA and \$35,471 from related PP organizations
