  - b(2) Cancelled checks for the past 36 months;
  - b(3) Records of deposits and transfers for the past 36 months.
- c) For each safety deposit box which each Judgment Debtor has had within the past 120 months:

  - c(2) A list of items removed from the box since the date of the judgment.
- d) For each Trust wherein any Judgment Debtor now is, or within 60 months was, a trustor, trustee, executor, beneficiary (or alternative of either):
