On 02/10/2011, at approximately 1515 hours, I made contact with All Women's Health Center of Gainesville via phone. I spoke first with Virginia and I identified myself and explained that I needed to speak with someone in regard to an aborted fetus that had not been disposed of yet and that I would like to collect. She asked me to hold and the line was then picked up by another employee who identified herself as XXXXXX. XXXXXX asked me what of the remains I needed. She alleged that after the procedure, the fetus was placed in sterile water and then into their freezer as biohazard waste. She also explained that a foot may have been placed in a jar and that they could give me a sample instead of the entire remains. XXXXXXX said that the child was seventeen weeks and that it was quite large. I advised XXXXXXX that I would call her back and let her know what I would need to take. She told me that they are in the middle of clinic and asked when I do come to use the back door. I explained to XXXXXXX that I had consent via phone from the mother of the child that the remains could be turned over to me in regard to this investigation. XXXXXX said that the mother also called her earlier today, and she inquired about the remains and told her that she had the police involved. XXXXXX said that they did not want to be involved in court related matters, but that she was satisfied with the phone consent the mother gave her and me to release the remains to me. Prior to going to the clinic, I met with the victim's mother who gave me written consent for the remains and any and all records from the clinic.

At approximately 1707 hours, I arrived at All Women's Health Center of Gainesville to recover the aborted fetus as evidence. At the clinic, I met with XXXXXX who turned the evidence over to me. Before leaving the room in the rear of the clinic, XXXXXX said to me, "Off the record, that girl had a serious attitude problem." She went on to tell me that at the time of the procedure, they had three staff people "fighting with her." She then said, "It seemed as if that wasn't her first time... so I'm just saying if it was rape, she can put up a fight." XXXXXXX then made a comment that the patient's parents were back and forth with each other and that her mother did not even stay for the procedure. I asked XXXXXX who was with her (meaning the victim) at the clinic for the procedure and she replied, "Her step-dad." I then asked if there was a medical record completed for the procedure and if I would be able to obtain a copy since the mother had signed the release which includes any and all medical records. XXXXXX advised me that there was a report completed, but said that if I could come back tomorrow, they could get me a copy of that record as it would take a little time to provide it and she has more patients to see this afternoon.

On 02/28/2011 at approximately 1100 hours I made contact via phone with the All Women's Health Center

of Gainesville. The phone was answered by Monica. I requested to schedule a time when I could meet in person with XXXXXX and Dr. Quintana. She explained to me that she would need to let me talk to XXXXXXX about this request since Dr. Quintana is not local and he comes in, does the procedures and leaves. XXXXXX then got on the phone. I reminded her that I was the detective that met with her the other day. (Note: I had met with XXXXXXX when I picked up evidence from the clinic to include the aborted fetus). She remembered me and advised that she and Dr. Quintana should be able to meet with me today. She expects him to come in at anytime and he will probably be in the office until 1:30 or 2 before he goes back to Tampa. After I told XXXXXXX that I would like to meet with she and Dr. Quintana separately to ask if the patient made any statements or other information that may be useful, XXXXXX asked me, "Do you actually expect the doctor to remember anything?" I explained to her that I would still like to meet with him in person and ask him myself.

On 02/28/2011 at approximately 1156 hours, I arrived at 1135 NW 23rd Avenue, Suite N (All Women's Health Center of Gainesville, Inc), to make contact with Jose Quintana and XXXXXX. I entered through the side door of the office as I had been asked to not come to the front lobby entrance. I met with an individual who confirmed that he was Dr. Jose Quintana. He asked me to come with him and we went to a very small room with a desk that was separated from the hallway via a curtain. I provided Dr. Quintana the medical record for the victim that I had obtained and briefed him about who was involved. He took the record and began looking through it and asked me "Was she a rape or something?" He asked me what I needed. I asked him if she ever discussed the origin of the pregnancy. He said that would be a question for the person who counseled with her which would have been XXXXXX. He denied that he discussed anything with this patient and said that he will just typically ask them if the patient has any questions. When asked if he knew how far along her pregnancy was, he said yes that she was sixteen and a half to seventeen weeks. I asked him if he knew how old she was when the she became pregnant. Dr. Quintana reviewed her date of birth and said that she was fourteen, but she would have been less at that time. Utilizing a pregnancy wheel, he said that she would have been pregnant "around October 20" and he confirmed that that would have been 2010, so she would have been thirteen years old. I asked him if he recalled if he or anyone like the counselor notified the Department of Children and Families in reference to her being thirteen and he said, "No." I also asked him if he knew of anyone notifying the Gainesville Police Department since I knew they are within the city, and he asked "the mother was... didn't file the report?" I told him that a report was filed later, after the meeting that he had on the 31st. He referred me to XXXXXX and said that she would have been the one to have that since she counseled her.

When asked if reporting would be something they would typically do, he said "yes it's a minor." He then told me that I should talk to the mother and he believed the mother had filed a report already and does not know why she wouldn't have. He denied knowing who was present with her other than the mother and said that I would need to ask XXXXXX that. When asked if there was any reason why he would not contact either DCF or law enforcement himself or ensure that someone did because she was under sixteen years of age, he said, "I believe that I was told... either it was reported already, because I usually say that, you're right, no reason, you have to report it, and I believe she said the mother had reported it." When asked when that was, he said he believed it was when he spoke to XXXXXXX but he seemed very unsure as he spoke with me. He then told me that XXXXXXX typically would do it, and said "We can do it from now on, report it no matter what." He alleged that he believed the mother may have told XXXXXXX that she reported it, and said I would need to ask XXXXXXX, and then he agreed that he has an "obligation" and it needs to be reported. I advised him that I planned on speaking with XXXXXX.

When asked if he had further information that may help me with my case, he said no and he asked if she had sex with her mother's boyfriend.

When asked where I could meet with XXXXXX, Dr. Quintana told me just stay here and he walked out of the office toward the front.

When a staff member walked by where I was waiting, I asked her if XXXXXX went outside (I had just heard the side door to the clinic opening and closing). She told me that she was actually talking to Dr. Quintana right now. I then walked toward the front office of the clinic and observed Dr. Quintana speaking to someone who was sitting behind a partition or cubicle wall. I heard the other voice and recognized it as XXXXXX. I could hear him telling her that "he" is asking about the girl and whether they notified anyone due to her age. I returned to the small office where I had met with Dr. Quintana and waited for XXXXXXX to meet me there.

When she walked up to me, XXXXXX immediately began talking about "the girl" and what she remembered. She said that the mother believed she was under 12 weeks but when she "sonogramed her" she was further along than that. She said the mother "had a really cocky attitude." When asked about the girl and if at any point they discussed the origin of the pregnancy, XXXXXX said "She didn't want to talk about it." She said the girl did not want to talk about it at all. XXXXXXX told me that she asked her if this was her decision and if she was being forced to do this. She said that she also told her that there were other agencies that would help her with the continuation of the pregnancy. XXXXXXX confirmed that while speaking with ______, the mother was always within listening distance and that the mother did most of the talking.

She denied that she recalled the child ever saying anything that made her believe she was assaulted. She then said "I did not get the feeling that it was rape." I provided her with her medical record and so she could review it. She said that she and Sarah were in the room during the sonogram and procedure and pointed toward a female that walked up (who was later identified as Sarah Muzzey). XXXXXX asked Sarah if she remembered anything about "this little girl" while showing her the medical record. XXXXXX said that it took three of them to do the procedure. Sarah then said "She fought." XXXXXX then read from the medical record that during the procedure she had to have three people in the room to hold her legs in order to do the procedure. When asked why, she said that she was under anesthesia and XXXXXX said "I think we made a comment on how in the hell did she get pregnant." Sarah said, "If it was what she said it was, she could have fought him off." XXXXXX then agreed with Sarah that she recalled her making that comment at the time of the procedure. They discussed using their strength to hold her down and they believed she was a track runner and was very strong. When I asked why she may have been so difficult, Sarah said, "Well I mean the procedure does hurt, but it's tolerable." When I said that I assume she gets meds, they described the pain medication that she was given (Valium, Stadol, and Versed) prior to the procedure and said "she still fought." Sarah described it as like drinking a bunch of beer and it was a large amount, so much so XXXXXX said that they had to "reverse her with Narcan." Sarah said, "Anybody else their oxygen would go low, their heat rate would go low, hers didn't." When asked, Sarah denied remembering her saying anything about the origin of the pregnancy, Sarah said, "I really didn't have any interaction with her at all that day until the procedure was fixing to be done and that's when you know I came in there, I mean I was drenched in sweat, and I'm like, dude, she if she got raped, she could have fought him off, no lie. And I asked her, are you a cheerleader or an athlete? She said I run track, and that was after all the sedation."

When asked if the child's mother said anything about how her daughter got pregnant, both XXXXXX and Sarah denied that she said anything to them. They denied remembering the daughter saying anything either. When asked if they were aware of her age, they looked at her date of birth and said she would have been fourteen. I asked them if they were aware of anyone from the facility notifying either DCF or law enforcement and they both denied that they did so. When asked if it is something they typically do, XXXXXX alleged that if the girl is under 16 and the guy is over 24, she would call the hotline anonymously. Dr. Quintana walked back up to us and said that he thought the mother said from the beginning that it was a boy at school.

XXXXXX and Sarah then discussed when they think they should call the hotline and XXXXXX complained that it would be too much to do, but since conception was when she was under 14 she should have. When asked about any license that XXXXXX had, she said she was an ORT. She spelled her first and last name for me. Sarah and XXXXXX told me that "Gina" Siksnius was also in the room.

Gina heard her name mentioned and walked over to speak to me. She spelled her last name for me and I was advised that she is a student training on her medical assistance degree. Sarah provided the spelling of her last name and advised that she was clerical staff.

They discussed the mother and the victim. They alleged that the mother has been very nice since the day of the procedure, but that she was a "bitch" that day. They denied being sure if there was someone else with the patient other than her mother. They denied that they have spoken to DCF and confirmed it was because a report was not filed.

I explained to the staff that the age of consent in Florida is 16. XXXXXX pulled out a sheet of paper with a statute pasted on it that contained part of 39.201(2)(d), F.S.S. which discusses the impregnation of a child under 16 by a person 21 or older solely under s. 827.04(3) the report does not need to be made to DCF.
