A licensee who has earned more than the 50 hours required for license renewal for the previous 24 month renewal period is allowed to carry over up to 25 hours to the next 24 month renewal period; OR</li> <li>One year of participation in an approved graduate medical education program; OR</li> <li>The AMA Physician's Recognition Award or the AOA CME certification (awarded within the 24 months immediately preceding the expiration date of your license).</li> <li>NOTE: If you answer "Yes" to question 8, you should answer "No" to the CE Waiver questions 6 or 7.
