On 12-17-15, I was dispatched to 12827 Ft. Caroline Rd. in reference to a disturbance.

Upon arrival, I met with the complainant, Patrick Kelly, who is a doctor (Gynecologist-at The Florida Women's Center). The complainant stated that he is in fear for his safety due to the two subjects, Ms. Gertrude Perez-Poveda and Mr. Brett Brunkenhoefer, standing in front of his property taking pictures of him and holding a large sign. The sign had a message on each side. The front side stated "Patrick Kelly..not a Gynecologist..just a abortionist" and on the other side the sign stated "Abortions Protect Incest,Child Rape, Human Trafficking". The complainant stated the subject's often stand in front of his place of employment, but feels they are taking it to another level when they come to his residence. The complainant stated due to recent shootings around the country involving doctors who perform abortions he is in fear of someone shooting him at his residence.

While driving to the complainant's residence the subjects were observed standing at the corner of Ft. Caroline Rd. and Mt. Pleasant.(approximately a quarter of a mile south of the complainant's residence) holding their sign. The subjects were contacted and questioned about the incident. Both subjects stated they have no intentions of harming the complainant, and simply want to bring him back into the "fold" of the Catholic faith. The subjects denied standing in front of his residence stating they know the law prohibits being stationary in front of a residence. The subjects admitted to taking pictures of the complainant, and were aware that taking pictures was not an illegal act.

The complainant requested a report to document the incident.
