Dear Sir/Madame:

The Wyoming Board of Medicine (Board) is in receipt of your email dated August 11, 2020, requesting "all the documents in the file pertaining to Marcela Smid, M.D., license 11710A."

As a State of Wyoming agency, the Wyoming Board of Medicine is not subject to the federal Freedom of Information Act; however, you also seek information "per the Wyoming public records law." Such a request is governed by the Wyoming Public Records Act, WYO. STAT. ANN. §§ 16-4-201 through 205. Pursuant to the act, the custodian of public records shall deny inspection of records if it is contrary to any state statute. WYO. STAT. ANN. § 16-4-203(a)(i).

Records of the Board are governed by the Wyoming Medical Practice Act (WYO. STAT. ANN. § 33-26-408(j)), and the Board's administrative rules (RULES, Ch. 6, § 3(a)), which specify what information held by the Board is "public record." Pursuant to that authority, I am able to provide the following information regarding Dr. Smid:

Licensure by Other States: *The Board's database shows that Dr. Smid has held licenses in Illinois, North Carolina, and Utah.*

Areas of Practice: *Dr. Smid reports practicing obstetrics and gynecology.*

Education: *Dr. Smid received her medical education at University of California, San Francisco, School of Medicine, graduating on June 12, 2009.*


Training (Postgraduate): *Dr. Smid received postgraduate training at the University of Chicago Program, Chicago, IL, completing internship training in Obstetrics & Gynecology on June 1, 2010 and completing residency training in Obstetrics & Gynecology on June 1, 2013. Dr. Smid also received postgraduate training at the University of North Carolina Hospitals Program, Chapel Hill, NC, completing fellowship training in Obstetrics & Gynecology/Maternal-Fetal Medicine on June 1, 2016.*

Specialty Board Certifications: *Dr. Smid held certification from the American Board of Obstetrics and Gynecology, granted on 11/01/2014, and expired on 12/31/2018.*

Professional Designation: *M.D.*

Any other records the Board holds regarding Dr. Smid's licensure file are not public documents, and are not subject to disclosure to any person or entity. WYO. STAT. ANN. § 33-26-408(f)(i). The information is also not subject to discovery in any civil or administrative action, except when necessary for further Board action, or in any action in which the Board may be named as a party or upon judicial review of a Board order. WYO. STAT. ANN. § 33-26-408(f).
