# **Medical Services: Milestones of 2013**

#### Milestone: 40,669 Medical Visits

In 2007, PPHS recorded more than 30,000 patient visits for the first time. This year, we achieved a new milestone: over 40,000 medical visits. The 2013 increase in patients is attributed entirely to greater demand for preventive family planning services.

#### **Milestone: Electronic Health Record (EHR)**

In 2013, three of our health centers migrated from paper medical charts to a sophisticated EHR platform. The new system provides powerful tools to enhance patient outcomes, collaborate with other medical providers and analyze patient trends. By next fall, all 12 PPHS health centers will be utilizing our Electronic Health Record system.

#### Milestone: Future Asheville Health Center

In 2013, we purchased and have since begun renovating a medical office building that will serve as the future home of our Asheville Health Center. The new center will enable us to see a higher patient volume and offer an expanded array of services. Based upon current fundraising projections, our future center is scheduled to begin operations in the late summer of 2014.

#### **Milestone: More Federally Funded Health Centers**

In 2012, PPHS succeeded in obtaining federal funding to provide subsidized family planning services in four of our North Carolina health centers. This year we received additional federal funding for our Virginia health centers in Blacksburg, Charlottesville and Roanoke. As a result, patients at or below 250% of poverty can now receive preventive family planning services at little or no cost. These preventive services include cancer screenings, annual exams, STD testing and treatment, and contraception.



# **Education: Milestones of 2013**

## **Milestone: Educator Telemedicine Program**

In 2013, PPHS initiated a unique grant-funded pilot that enables our education clients to remotely receive contraceptive services. This innovative program uses video conferencing and virtual private network (VPN) technology to enable a PPHS clinician to provide services to education clients in communities that lack access to family planning services. Education staff facilitates the process and assists the clinician by recording vital signs and obtaining a complete patient history.


#### **Milestone: Community Expansion**

In the spring of 2013, PPHS received grant funding to add a part-time Community Health Educator to provide preventive educational services to at-risk youth and young adults in Winston-Salem. During the summer, we also expanded our Education program in Asheville. Our ten Educators customize their efforts to best address community need. For instance, unintended pregnancy and access to contraceptives are of particular concern in Asheville and the surrounding counties. The greater Winston-Salem area shares similar concerns and also experiences high rates of sexually transmitted infections.

#### **Milestone: Health Center Integration**

One of our Educators' primary goals is to encourage at-risk clients to obtain preventive health care services from Planned Parenthood or another trusted provider. Throughout 2013, PPHS surveyed all first-time patients to determine which had been motivated to seek medical care after receiving PPHS educational services. As of December 2013, PPHS recorded 703 education clients that had scheduled new appointments to receive reproductive health care and one-on-one counseling with a clinician. This innovative program was recently nominated for a Planned Parenthood Federation of America Affiliate Excellence Award.

## **Milestone: Promoting the Affordable Care Act**

Public Affairs staff led our affiliate-wide efforts to assist our clients obtaining health care coverage through the Affordable Care Act (ObamaCare). They trained our entire staff on the nuances of the law. They also hired paid interns to oversee Internet kiosks in our waiting rooms so patients could sign up for health care coverage on line. The Public Affairs Department continues to lead our legislative efforts to expand Medicaid coverage in all four of our states.

## Milestone: Legislative Successes in West Virginia

PPHS, our coalition partners and our advocates in West Virginia lobbied to ensure passage of the "Maternity Coverage for Dependent Daughters" law. The law requires employee health insurance plans that provide coverage for maternity care and contraception to extend that coverage to dependents. The state also repealed an antiquated law allowing for the involuntary sterilization of people with mental illness. In 2013, West Virginia became the first of our states to expand Medicaid under federal health care reform. This will extend medical coverage to tens of thousands of low-income families.

#### **Milestone: North Carolina TRAP Law**

Despite the efforts of thousands of volunteer advocates, North Carolina passed Targeted Regulation of Abortion Providers (TRAP) legislation in 2013. The new law will likely lead to the closure of many women's health centers around the state. Similar laws in Virginia and South Carolina have greatly impinged on women's access to reproductive health care.

## **Milestone: Virginia Election Victories**

The Planned Parenthood Health Systems Action Fund joined with Planned Parenthood Advocates of Virginia and the national Planned Parenthood Action Fund in a statewide effort to prevent Planned Parenthood opponent Attorney General Ken Cuccinelli from becoming Governor. The Keep Ken Out campaign was instrumental in helping to elect Terry McAuliffe as Governor. Planned Parenthood's endorsed candidates for Governor, Lieutenant Governor and Attorney General were all elected in November.

#### **Milestone: Largest Individual Gift in our History**

# Milestone: Launch of our Planned Giving Program

We also established a more formalized approach for honoring planned giving supporters and their commitment to Planned Parenthood—now and in the future. 
