### Narrative

On January 2, 2018 at 1658 hours I was dispatched to 522 Lomas Blvd NE (South Western Woman's Options) in reference to a contact call. The caller reported a 15 year old female, Alexis Ruelo, had intercourse with a 16 year male. The incident occurred in Chicago Illinois. The caller reported they were also "state mandated" to report the incident.

Once I arrived on scene I met with Alexis Ruelo and her mother, Heather Navea. We were escorted to a conference room at the facility by staff. Alexis was surprised that police had been called to the medical facility. She told me she had sexual intercourse with her boyfriend and got pregnant back in June. The intercourse was consensual by both her and her boyfriend. She later found out she was pregnant but she was too far along to terminate the pregnancy in Chicago. She reported she flew to Albuquerque to get an abortion. Alexis did not want to give me any information pertaining to her boyfriend.

Heather stated that they were only here in Albuquerque to terminate the pregnancy. She knew that Alexis had sex with another juvenile and got pregnant. She was not aware that police had been called and was also surprised to see the police.

I contacted Detective Navia with Chicago Police and briefed him on the call. I emailed Detective Navia a copy of this police report.
