Narrative

On the above date and time MS SAYLES advised she was a client at Planned Parenthood, at which time, she went into the restroom, at which time, she placed her keys and other belongings on the chair next to the restroom, where there were other employees sitting. MS SAYLES visited Planned Parenthood on 1-19-21 between the hours of 1400 and 1600. She did not know who the employees were. MS SAYLES stated once she was left the restroom, she continued the process of speaking with the Doctor at the facility.

Once she finished the process, she returned to work and this is when she noticed her iPod was not connected to her keychain. She checked everywhere she could and was unable to locate the iPod. Then she backtracked and contacted Planned Parenthood and also went back to the facility to try and locate her iPod. She was unsuccessful in locating the iPod. She stated she did speak with a male at Planned Parenthood, but is not sure who the male was. She believed he was some type of Security Guard. He had an office as soon as you walked into Planned Parenthood on the left hand side. She asked about videos, where the male stated they probably have video, but he was not in any hurry to assist her in looking at the video and seeing who may have taken her iPod.

She stated the gentleman also advised no one had turned in any iPod to the front desk. I gave MS SAYLES the case number and advised if she has any additional information, to contact the WPD and reference that case number.
