On the listed date and time, I responded to in reference to a disturbance.

Upon arrival, I met with (Victim) who was waiting outside, near the front entrance of told me, earlier that evening, he was in office when Kelly Flynn (Suspect), entered the room and began cursing and threatening him. stated he motioned with his phone indicating he was recording the escalating altercation. advised he left to avoid the confrontation and Kelly followed him and attempted to wrestle his phone away. During the struggle, stated Kelly grabbed him behind the neck. had red scratch marks on the left side of his neck consistent with his statements. further advised Kelly had been drinking alcohol for much of the day.

I then met with Kelly Flynn. Post Miranda, Kelly admitted she and did have an argument that resulted in her attempting to take phone. Kelly denied scratching neck but could not provide an explanation as to how the marks appeared. Kelly frequently used profanity when speaking and stated accusations were an attempt at retaliation for him with It should be noted, I could smell the odor of an alcoholic beverage on Kelly's breath as she spoke.

Due to the statements of both and Kelly, as well as injuries, probable cause was established to place Kelly under arrest for domestic battery. She was transported to jail and turned over to booking staff without incident. Deputy C. Griffin (4222) provided with a Victim's Rights Brochure. Both a domestic violence blue card and victim's audio statement are attached to this report. Photos of injuries were submitted into evidence.

On 12/18/19 at 2:12 p.m., I received a call from District Sergeant Gazdick informing me \_\_\_\_\_ was at the Northeast Field Office and wished to meet with me regarding turning over K. Flynn's medication.

Upon arrival, I met with \_\_\_\_\_ who stated his attorney advised him to turn over K. Flynn's medication to a deputy. I took possession of a white sealed envelope with a "Drop-Off of Confidential Case Exhibit" affidavit affixed to the outside. I determined there were four pill bottles inside, 2 of which were empty. The first empty bottle was labeled "Amphetamine Salts", 10mg. The second empty bottle was labeled Trintellix, 10 mg. The third bottle, also labeled "Amphetamine Salts" contained one 20 mg capsule, yellow/orange in color. The fourth bottle was labeled Alprazolam, .5 mg, however, it contained multiple different medications. The fourth bottles contents are listed below:

10 Blue, oval shaped pills with a lower case "b" above the number 972 on one side, and 1 0 on the other side.

3 Amphetamine salts that matched the single pill in the third bottle.

1 light blue capsule with unknown writing


2 1/2 light orange pills with the letter "Y" on one side and 1 9 on the other.

1 white "capsule shaped" pill with I 10 on one side.
