Settlements

Settlement payments will appear in this profile only if the total number of settlements made within the past ten years is equal to three or more. High/Low Agreements

Increasingly more and more popular in civil litigation, plaintiffs and defendants, prior to going to trial, will enter into "high-low agreements."

The agreement sets a maximum amount (the "**high**" amount) that a defendant will pay to the plaintiff, if the judgment is **against the defendant**. In return for

agreeing to this cap on the damages award, the agreement provides for a minimum amount (the "**low**" amount) that the defendant will pay to the plaintiff, if the judgment is **against the plaintiff**.

The jury is not told of the agreement and only issues the verdict, which is the sole judgment of the court. The award is made pursuant to the terms of the high-low agreement and, is therefore, considered to be a settlement agreement.

The doctor's malpractice history

Above is information about the doctor's malpractice history during the last ten (10) years. Malpractice means a professional mistake that is a direct cause of injury or harm to the patient. A malpractice history has information about payments made within the last 10 years when a patient thought the doctor did a medical job poorly.

What's in the Malpractice History

1. Information about payments the doctor has made after a legal action has started. It is important to know that in some medical specialties, doctors have more legal actions brought against them than in others, and make more payments as a result.
2. The dates on which payments were made, and the region where the action occurred.



On the chart above, we compare the doctor's payments with those of other New York doctors who practice the same medical specialty (doctors who are in the same field), and who practice in the same geographical area. We give the doctor a comparison rating of below average, average or above average.

- Below average means the doctor has made a payment that is less (in amount) than New York doctors in his or her field and in the same geographical area.
- Average means the doctor has made a payment that is about the same amount as most New York doctors in his or her field and in the same geographical area.
- Above average means the doctor has made a payment that is higher (in amount) than other New York doctors in his or her field and in the same geographical area.

Why Some Doctors Pay More

As you read the doctor's malpractice history, remember the following:

- Some doctors work with high-risk patients. These doctors may have malpractice histories with many payments because they specialize in cases or patients who are at very high risk for problems.
- A doctor may choose to pay a patient even though he or she did not make a mistake. When a doctor pays a patient it does not mean that the doctor is guilty of malpractice.

The malpractice information on this site is for the last ten years. If a doctor has been working fewer than ten years, this malpractice history covers all of that time.

We encourage you to talk with the doctor about the information in this report.
