Filing 66 ORDER GRANTING PLAINTIFFS' MOTION FOR PRELIMINARY INJUNCTION - Plaintiffs ask the Court to enter a preliminary injunction prohibiting the State of Indiana from enforcing a new law that would require qualified abortion clinic personnel to recite specific language to women seeking a medication abortion. Medication abortions involve a two-drug regimen, with the first prescription (mifepristone) taken 24 to 48 hours before the second (misoprostol). Plaintiffs' motion for a preliminary injunction is GRANTED. Dkt. #5 . Pursuant to Federal Rule of Civil Procedure 65, a separate order consisting of the preliminary injunction shall issue contemporaneously with this Order (SEE ORDER FOR ADDITIONAL INFORMATION).
