assistants in reproductive health care; and for related purposes.

In furtherance thereof, the corporation may receive property by gift, bequest or devise, invest and reinvest the the same, and apply the income and principal thereof, as the Board of Directors may from time to time determine, and engage in any lawful act or activity for which corporations may be organized under the Kansas Nonprofit Corporation Act.

The corporation hereby consents, without power of revocation, that actions may be commenced against it in the proper court of any county in the state of Kansas where there is a proper venue by service of process on the Secretary of State of the state of Kansas; and the corporation stipulates and agrees that such service shall be taken and held in all courts to be valid and binding as if due service had been made upon an officer of the corporation.


