NARRATIVE

SUMMARY:

On 9-28-21 I was contacted by Det Kyle Brownfield from the St. Joseph County (Indiana) Special Victim`s Unit. I assisted Det Brownfield by drafting and serving a search warrant at Planned Parenthood - Kalamazoo Health Center to obtain the aborted fetus from [REDACTED] who is a 13-year-old victim of a CSC 1rst in St. Joseph County, IN. The fetus was collected on 10-8-21 by Det Brownfield and brought to Indiana for analysis.

CONTACT WITH ST JOSEPH COUNTY SPECIAL VICTIM`S UNIT (DET KYLE BROWNFIELD):

On 9-29-21 your I was contacted by Det Kyle Brownfield from the St. Joseph County Special Victims Unit in Indiana. Det Brownfield advised that he is currently investigating a CSC case which occurred in St Joseph County Indiana in which a 13-year-old victim had been impregnated.

Det Brownfield stated the victim was going to terminate the pregnancy and scheduled an abortion to be conducted at the Planned Parenthood - Kalamazoo Health Center located at 4201 W Michigan ave, Kalamazoo, MI on 10-8-21 at 1110 hours.

Det Brownfield drafted a search warrant in St. Joseph County Indiana for the product of conception to be collected as evidence of the CSC that occurred in Indiana and was advised that the authority of the search must be conducted by an agent or officer having jurisdiction in the City and County of Kalamazoo, State of Michigan. Det Brownfield requested my assistance in drafting a search warrant in the State of Michigan and County of Kalamazoo so the search could be conducted, and the product of conception could be collected.

SEARCH WARRANT:

On 10-1-21 I drafted a search warrant for the `produce of conception representing the child from [REDACTED]`s scheduled in-clinic surgical abortion` at Planned Parenthood - Kalamazoo Health Center located at 4201 W Michigan ave. The search warrant was reviewed and signed by Judge Ankley.

I forwarded the signed search warrant to Det Brownfield and he made arrangements with the victim`s family and Planned Parenthood for the fetus to be collected after the procedure was completed.

EVIDENCE:

Det Brownfield took custody of the `product of conception` and brought it immediately to St Joseph County lab for analysis.

ATTACHMENTS:

I attached a copy of the Michigan and Indiana search warrant to this supplement.

CASE CLOSURE:

I recommend this case be closed - inactive, AOJ.

Det Brownfield requested my assistance in drafting a search warrant in the State of Michigan and County of Kalamazoo so the search could be conducted, and the product of conception could be collected.

Det Brownfield's probable cause for the search warrant and affidavit stated the following:

"INTRODUCTION AND INVESTIGATOR BACKGROUND

I, Detective Kyle Brownfield, upon information and belief, affirm under the penalty of perjury that: I am a Detective with the South Bend Police Department, assigned to the Special Victims Unit of St. Joseph County. I have been an Officer for the South Bend Police Department since November of 2013. I have been an investigator with the Special Victims Unit since March of 2020.

The statements in this report are based on my personal knowledge, and on information that I have received from other law enforcement personnel and from persons with knowledge regarding relevant facts of this investigation. I have not included each and every fact known to me concerning this investigation. I have only included facts necessary to establish probable cause of a violation of Indiana Code 35-42-4-3.

FACTS OF THE INVESTIGATION

The reasons and grounds for affiant's belief that there exists probable cause for searching said premises are as follows:

On 09/27/2021 this Detective was assigned an investigation involving [redacted] and her mother, [redacted]. [redacted] is 13 years of age. In the original police report, [redacted] stated she took [redacted] to the hospital for evaluation as she had been throwing up for approximately 1 month. [redacted] was seen at Memorial Hospital. After a battery of tests, it was found that [redacted] was approximately 6-8 weeks pregnant.

[redacted] began questioning [redacted]. [redacted] was not forthcoming with information to [redacted] but eventually identified an approximately 16 year old cousin, and an approximately 13 year old half brother as having "touched her." [redacted] did not elaborate further.

█████ then took █████ to the St Joseph Regional Medical Center for a SANE evaluation.

During the evaluation, █████ made the following statement to nursing staff:

"Patient states both (suspect's) penises went inside her vagina."

The following day, █████ took █████ to the Women's Care Center. During this visit, it was confirmed that █████ was not only pregnant, but approximately 13 weeks and 1 day pregnant.

During her forensic interview, █████ identified 2 half brothers, as well as a cousin, as having put their penises inside of her.


█████ is scheduled for an in-clinic surgical abortion to terminate the pregnancy on October 8, 2021. The product of conception representing the child is needed for paternity analysis. A representative sample(s) of the product of conception is to be collected, which may include umbilical cord blood, a portion of the placenta, and/or other tissue samples.

1. The product of conception will be collected and placed in a collection container at the Planned Parenthood - Kalamazoo Health Center by the health care professionals at Planned Parenthood - Kalamazoo Health Center located at 4201 W Michigan Ave, Kalamazoo, Michigan 49006.
2. At this time it is respectfully requested that enough probable cause has been met to allow the investigators of the St. Joseph County Special Victims Unit to enter the premises of Planned Parenthood - Kalamazoo Health Center (4201 W Michigan Ave, Kalamazoo, Michigan 49006) to search and recover the following item: collection container containing the product of conception representing the child from █████ scheduled in-clinic surgical abortion.


