Dr. Reeves is a licensed physician and is board certified in obstetrics and gynecology. Dr.

Reeves has experience and has provided consultation, care, and treatment in the field of obstetrics

and gynecology within five (5) years of the date of the circumstances giving rise to this claim. Dr.

Reeves has reviewed the Complaint, medical records, and other relevant material pertaining to the

care and treatment rendered to Ms. Haimanot Aragaw in the above-captioned action. It is

anticipated that Dr. Reeves will review additional pertinent material as it becomes available

through the discovery process in this matter. Dr. Reeves's testimony will address the issues of

standard of care, causation and damages. It is anticipated that Dr. Reeves will testify that the

agents (actual and/or apparent), servants and employees of AbortionClinics.org, a/k/a

AbortionClinics and/or ACO Incorporated and ACO Incorporated, d/b/a AbortionClinics.Org, Inc.

and/or AbortionClinics, including but not limited to Dr. Leroy Carhart, Jr., complied with accepted

standards of care with regard to his involvement in Ms. Aragaw's case. It is further anticipated

that Dr. Reeves will testify that no act or omission on the part of Dr. Carhart was a proximate cause

of injury to Mrs. Aragaw as claimed.

Ms. Aragaw presented to Abortion Clinics (ACO Incorporation) on May 20, 2020, for a planned abortion of a 24 week/3 day gestational age fetus. The abortion was planned due to the fetus testing positive for the chromosomal abnormality trisomy 21 (Down Syndrome). On May 15, 2020, Ms. Aragaw signed each page of an extensive informed consent document which identified known and material risks of the procedure. It is anticipated that Dr. Reeves will testify that the informed consent process was completed appropriately and within accepted standards of care. On May 20, 2020, Ms. Aragaw was seen for insertion of laminaria. The laminaria placement was without complication. Ms. Aragaw was instructed to return the following day for the planned extraction. On May 21, 2020, Ms. Aragaw arrived at the clinic at approximately 9:11 am. Artificial rupture of membranes was accomplished at 9:57 am. Ms. Aragaw tolerated removal of the laminaria but began to have bleeding. Ultrasound evaluation revealed a low lying placenta. Upon further evaluation, the decision was made to continue with dilation and evacuation. It is anticipated that Dr. Reeves will testify that this was appropriate and within accepted standards of care. As the procedure continued, Ms. Aragaw reported being uncomfortable and with some pain. Dr. Carhart was called to assist. Ultimately, the procedure was stopped due to concern for possible perforation and Ms. Aragaw was transported to Shady Grove Adventist Hospital for further management. It is anticipated that Dr. Reeves will testify that this was appropriate and within accepted standards of care. While at Shady Grove, Ms. Aragaw underwent an exploratory laparotomy which revealed a uterine fundus avulsion from 2 to 10 o'clock around the circumference of the cervix with incomplete surgical abortion and injury to the appendix. Pathologic evaluation confirmed a diagnosis of placenta accreta. Ms. Aragaw was discharged from Shady Grove Adventist Hospital on May 25, 2020.

It is anticipated that Dr. Reeves will testify that the complication encountered during Ms. Aragaw's procedure is a recognized complication of the procedure itself and does not represent a breach from accepted standards of care on the part of the health care providers caring for Ms. Aragaw. In addition, it is anticipated that Dr. Reeves will offer testimony regarding the general medical issues relevant to this matter. Dr. Reeves's opinions will be based upon his education, training, and experience, as well as his review of the medical records and other relevant material produced during discovery. It is anticipated that Dr. Reeves's opinions will be expressed to a reasonable degree of medical probability. To the extent necessary and/or appropriate, it is anticipated that Dr. Reeves experts will respond to and rebut the opinions of the Plaintiffs' expert witnesses. Specifically, but without limitation, it is anticipated that Dr. Reeves will respond to and rebut each of the allegations of negligence asserted on behalf of the Plaintiffs by C. Brent Boles, M.D. and/or Forest Owen Smith, M.D. Specifically, but without limitation, it is anticipated that Dr. Reeves will respond to and rebut any assertion that Dr. Carhart and/or the agents (actual and/or apparent), servants and employees of AbortionClinics.org, a/k/a AbortionClinics and/or ACO Incorporated and ACO Incorporated, d/b/a AbortionClinics.Org, Inc. and/or AbortionClinics breached the standard of care in the informed consent process or in the performance of the procedure or in the management of Ms. Aragaw once the complication was encountered.
