of the law of little importance to the American people. Rather, wielding nothing but 'raw judicial power,' . . . the Court usurped the power to address a question of profound moral and social importance that the Constitution unequivocally leaves for the people."

"We can only do our job, which is to interpret the law, apply longstanding principles of *stare decisis*, and decide this case accordingly. We therefore hold that the Constitution does not confer a right to abortion. *Roe* and *Casey* must be overruled, and the authority to regulate abor-

tion must be returned to the people and their elected representatives."

"Abortion presents a profound moral question. The Constitution does not prohibit the citizens of each State from regulating or prohibiting abortion. *Roe* and

Christy Boraas-Alsleben is an abortionist with Planned Parenthood in Minnesota who is currently involved in a research study regarding the abortion pill. Many abortionists across the country are sending women abortion pills through the mail after a phone call or video conference. No physical exam or ultrasound is done, thanks to the Food and Drug Administration (FDA) under Biden.

This current study being conducted in Minnesota and Colorado goes one step further in streamlining the process of killing the baby and potentially causing dangerous complications to the mother. In this study, the pregnant woman doesn't speak with the abortionist at all. She simply fills out an online questionnaire which is then reviewed by Boraas-Alsleben or another abortionist, who then decides if the woman is "eligible" to be sent the abortion pills in the mail.

Please pray for Boraas-Alsleben that she would stop looking for ways to make it easier for women to kill their children and instead focus on ways to make it easier for them to choose life! Pray also that she would repent of the abortions she has done so far and turn to Christ for healing and restoration.

Is Your Doctor Involved in Abortions?

Ask your doctor if he/she does abortions or refers for them, or prescribes abortifacients such as the Pill, Ortho Evra (the "patch"), Depo-Provera (the "shot"), Nuva-Ring, the "morning-after pill," implants, or the IUD. All these methods (and others) can cause very early abortions by thinning the lining of the uterus so that if breakthrough ovulation occurs (which is possible) and a new life is conceived, the young human being may not be able to attach to the uterine lining and therefore he or she dies.
