**JOINT STATUS REPORT  
PURSUANT TO COURT’S JANUARY 21, 2022 ORDER**

---

On May 26, 2021, the Court, ruling on an unopposed motion, ordered this appeal held “in abeyance pending a decision of the Supreme Court” in *Dobbs v. Jackson Women’s Health Organization*, No. 19-1392 (U.S. May 17, 2021). The Supreme Court granted certiorari in that case to address the question: “Whether all pre-viability prohibitions on elective abortions are unconstitutional.”

This Court further ordered that the parties provide a status report 120 days after the May 26, 2021 Order, and the parties filed that report on September 23, 2021. On September 24, 2021, the Court ordered the parties to file another status report by January 24, 2022, and the parties filed that report on January 21, 2022. On January 21, 2022, the Court ordered the parties to file another status report by

May 24, 2022. Therefore, the parties hereby report to the Court that the Supreme Court has not issued a decision in *Jackson Women's Health*.

The parties propose that they provide another status report to the Court within 10 days of any Supreme Court decision in *Jackson Women's Health*.
