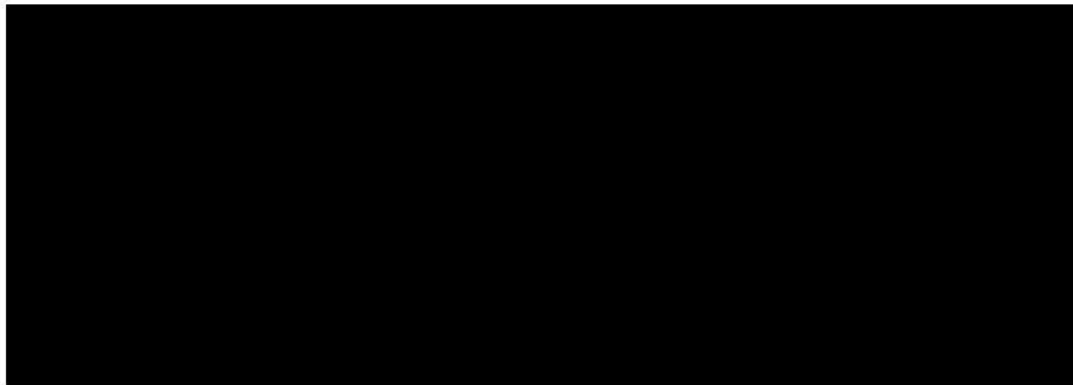

DIGITAL ISSUE; [REDACTED] UNK CLINIC STAFF AT AMERICAN WOMEN'S MEDICAL CENTER THE FOLLOWING IS A GENERAL SUMMARY OF R/O'S RECOLLECTION OF EVENTS AND ALL CONVERSATIONS WITHIN ARE NOT VERBATIM.

IN SUMMARY, COMPLAINANT [REDACTED] ONDED TO THE DPPD COMPLAINT DESK REGARDING A REPORT OF A CITIZEN ASSIST. [REDACTED] WISHED TO REPORT SOME ISSUES THAT SHE HAD EXPERIENCED WITH HER ABORTION AT [REDACTED] N WOMEN'S MEDICAL CENTER (ABORTION HEALTH CENTER) AT 110 S. RIVER RD., STE. 7.

[REDACTED] SAID THAT SHE HAD INTENDED TO RECEIVE AN ABORTION AT THE AMERICAN WOMEN'S MEDICAL CENTER (THE CLINIC) DURING AN UNKNOWN AFTERNOON HOUR IN [REDACTED] 2021. [REDACTED] DID NOT KNOW ON WHICH DATE SHE HAD TRAVELED TO THE CLINIC FOR HER ABORTION PROCEDURE, BUT WAS CONFIDENT THAT IT WAS IN [REDACTED] 2021 DURING THE AFTERNOON. [REDACTED] RECALLED TALKING ON THE PHONE FOR APPROXIMATELY FOUR HOURS OUTSIDE OF THE CLINIC PRIOR TO HER ABORTION APPOINTMENT. MOREOVER, [REDACTED] NOT RECALL THE NAME OF THE DOCTOR WITH WHOM SHE HAD SCHEDULED SAID APPOINTMENT.

[REDACTED] WHO WAS APPROXIMATELY [REDACTED] AT THE TIME OF THE PROCEDURE IN [REDACTED] 2021, NOTED THAT SHE HAD CHANGED HER MIND REGARDING THE PROCEDURE INSIDE HER INITIAL TREATMENT/EVALUATION ROOM. ACCORDINGLY, [REDACTED] WISHED TO DEPART FROM THE CLINIC. A MALE [REDACTED] DOCTOR (WHOM [REDACTED] BELIEVED WAS OF [REDACTED] HERITAGE) AND A [REDACTED] FEMALE [REDACTED] NURSE NAMED [REDACTED] REFUSED TO PERMIT [REDACTED] TO LEAVE THE CLINIC—AND NOT GO THROUGH WITH HER ABORTION. BOTH PUSHED [REDACTED] BACK INTO HER PROCEDURE CHAIR AND INJECTED SOME KIND OF ALLEGED ANESTHETIC DRUG OR ANESTHESIA INTO [REDACTED] LEFT ARM/WRIST AREA. [REDACTED] SAID THAT SHE HAD REMEMBERED THE ABOVE DRUG INJECTION OCCURRING INSIDE THE INITIAL TREATMENT/EVALUATION ROOM.

FOLLOWING THE INJECTION, THE ABOVE DOCTOR AND NURSE DUO IMMEDIATELY ASSISTED [REDACTED] WITH SLOWLY WALKING TO THE OPERATING TABLE FROM THE INITIAL TREATMENT ROOM AS

██████████ WAS "DOZING OFF" FROM THE ANESTHETIC. ██████████ BELIEVED THAT SHE HAD THEN BECOME UNCONSCIOUS ON THE OPERATING TABLE AS HER ABORTION PROCEEDED. ██████████ ALSO REMEMBERED ██████████ BEING IN THE ROOM WHEN ██████████ LATER AWOKE. ██████████ INTIMATED THAT ██████████ HAD CONSOLED ██████████ FOLLOWING THE ABORTION COMPLETED WITHOUT ██████████ CONSENT.

██████████ NOTED THAT SHE HAD BEEN RECENTLY SEEKING LEGAL COUNSEL REGARDING THE PROCEDURE, AND BOTH THE APPARENT UNLAWFUL RESTRAINT (CHPT. 720 ILCS 5/10-3) AND THE APPARENT AGGRAVATED BATTERY (CHPT. 720 ILCS 5/12-3.05 (A) (1)) COMMITTED AGAINST HER BY UNKNOWN CLINIC STAFF. PROSPECTIVE ATTORNEYS ALLEGEDLY TURNED ██████████ AWAY DUE TO THE ABOVE CRIMES' STATUTES OF LIMITATIONS EXPIRING. ██████████ NOTED THAT SHE WANTED "JUSTICE" REGARDING THE ABOVE CHARGES, IN ADDITION TO POSSIBLE INTENTIONAL HOMICIDE OF AN UNBORN CHILD (CHPT. 720 ILCS 5/9-1.2) AND AGGRAVATED BATTERY TO AN UNBORN CHILD (CHPT. 720 ILCS 5/12-3.1 (A-5)) CHARGES.

██████████ SAID THAT HER NEARLY FOUR-YEAR DELAY IN REPORTING THE ABOVE EVENT TO THIS AGENCY WAS BORNE BY A LACK OF SUPPORT ("NOBODY AROUND ME SUPPORTED ME."). AGAIN, ██████████ INDICATED THAT SHE WOULD BE A WILLING COMPLAINANT.

R/O APPRISED ACTING W/C SGT. DICKSON #783 AND SGT. BONIAK #794 OF THE ABOVE ALLEGATIONS MADE BY ██████████ AGAINST UNKNOWN CLINIC STAFF. AGAIN, ██████████ COULD NOT TENDER FURTHER INFORMATION REGARDING HER ABORTION PROCEDURE IN ██████████ 2021, INCLUDING THE ATTENDING DOCTOR'S NAME AND THE POSSIBLE ROOM NUMBER WHEREIN THE PROCEDURE HAD OCCURRED.
