Narrative

On 5/15/2023 at approximately 1515 hours, I, Officer B. Parrish, responded to Planned Parenthood, located at 455 W. 5th St, to take a sexual assault report. The assault took place in [REDACTED], therefore the report was taken as a courtesy for [REDACTED].

Upon arrival, I met with the victim, [REDACTED], and her friend, [REDACTED] stated the following:

She met a male, identified as [REDACTED] online. [REDACTED] and [REDACTED] chatted online for awhile and she decided she liked him. [REDACTED] lives in Arizona but bought a plane ticket to come visit [REDACTED] for the weekend at her home, located at [REDACTED], in [REDACTED]. [REDACTED] arrived at [REDACTED] home on 3/23/23 or 3/24/23. [REDACTED] and [REDACTED] engaged in unprotected consensual sex, and [REDACTED] ejaculated inside [REDACTED]. [REDACTED] was upset and told [REDACTED] he could never do that again, because she was not on birth control for health reasons, and she was not okay with him doing that. They engaged in unprotected consensual sex approximately two more times throughout the weekend, but [REDACTED] stated [REDACTED] "pulled out" during those occasions, and did not ejaculate inside her. On 3/28/23 or 3/29/23, she and [REDACTED] again engaged in unprotected consensual sex, however [REDACTED] again ejaculated inside [REDACTED]. [REDACTED] stated that on 3/28/23 or 3/29/23, she would have been ovulating, so she was especially upset that he had done so because she had previously told him not to, as she did not want to get pregnant. [REDACTED] got upset and left her home, leaving [REDACTED] there with her roommates. When she returned, she stated [REDACTED] threw her onto her bed, ripped off her pants, and smelled her genitalia, "to see if she had been with another guy." [REDACTED] ran out of her room, and told her male roommate, [REDACTED], to make [REDACTED] leave. They did, and he has not attempted to contact [REDACTED] again.

[REDACTED] later found out that she was pregnant as a result of her interactions with [REDACTED] and repeatedly attempted to contact him via Facebook, Instagram, and text messaging, to inform him of what had happened, however she received no response.

[REDACTED] received a medical procedure to terminate her pregnancy. [REDACTED] wanted to obtain DNA for law enforcement to collect, so she elected to have the procedure in-clinic at Planned Parenthood. The products of conception were placed in a collection container and sealed. I sealed the container with evidence tape and signed the tape, then photographed the contents and the evidence seal. The products need to be kept frozen so Planned Parenthood agreed to maintain custody of the products. They were advised to call [REDACTED] if the products were not picked up in a timely manner, and provided their contact information.

Based on the information provided above, the circumstances [REDACTED] described do not meet the statutory requirements of sexual assault in the State of Nevada, therefore, the report type has been listed as "Incident" and [REDACTED] has not been listed as a suspect. This report was taken for documentation purposes and should be forwarded to [REDACTED] for their review.

Photographs were uploaded to Axon Capture under this case number.

[REDACTED] was provided a case information sheet, and a Sexual Assault Bill of Rights pamphlet.
