Dear Complaint Dept.,

My complaint is against the license of Marilee Hanson, License #: CP072 which was issued March 1, 2023.

This licensee has a pharmacy dispensing practitioner license under now deceased Garry Siegel, M.D. for the location of 1002 W. Mission Ave, Bellevue, NE 68005.

On July 6, 2023 the State Investigator inspected this location and in the Pharmacy Quality Assurance Report found the infractions of Marilee Hanson illegally prescribing drugs under the dispensary practitioner license of Garry Siegel which was CP 179.

The report stated:

"Inspector found multiple prescriptions dispensed by Dr. Hanson that were labelled with Dr. Siegel's name..."

Her practice includes Induction Abortion Care Up to 35 weeks.

This licensee has had licenses in Colorado, Massachusetts, Minnesota, California and Hawaii too.

This licensee has also been sued before in Minnesota:

Christopherson v. Hanson

She's been sued in Massachusetts too:

Mananda v. Hanson

This involved delaying a C-section, which caused permanent brain damage and injuries to the baby.

Also her own ex-employee sued her for unpaid vacation and in the suit Pamela Ramsey proclaimed she even reported her to the Minnesota Medical Board too.

Also this licensee has accepted drug company benefits in the past: \$12.19. She has no moral compass. Isn't this a conflict of interest?!

This licensee is not above the rules, regulations and laws. It is questionable if she was impersonating Siegel and using his identification as her own to prescribe drugs.

She has not complied with what she signed and protocol.

It is unknown how many other complaints have been lodged against her license. Please check on this. This licensee lacks moral character. She is not a newbie physician and has even owned her own practice in Minnesota previously. She violated this protocol intentionally for profit. She should not be putting profit above the health and safety of women and teenage girl patients. This licensee is incompetent. The public deserves better. This is unacceptable.

Inaction by the state indicates the state could be held liable if a lawsuit is submitted to the court.

Please let me know what immediate action you will take. Please let me know what my complaint number is and the final results.
