# Response of Ryan J. Montoya to Trustee's Objection to Claim No. 57

Now comes Ryan J. Montoya ("Montoya"), through counsel, and hereby makes this Response to Trustee Mark G. DeGiacomo's Objection to Claim No. 57, Docket No. 212, (the "Objection"), pursuant to Fed. R. Bankr. P. 3007 and MLBR 3007-1(c). Montoya contests the Objection only with respect his filed claim as amended, Claim No. 57. Montoya asserts that the Objection should be overruled for the following reasons: 1) Montoya contributed funds to fund the retirement account balance which composes part of the claim, including, but not limited to, by depositing the balance of a previous IRA. Pursuant to MLBR 3007-1(c), Montoya attaches documentation of this deposit as Exhibits A and B; 2) Montoya is also owed money from the Debtor for services rendered pursuant to a written contract; 3) Montoya does not owe the Debtor money and his claim is not subject to disallowance pursuant to 502(d) – this issue is the subject of a pending adversary against him (and other defendants) in this Court, at Docket No. 18-AP-01019, which remains unresolved pending trial. Montoya respectfully suggests that the 502(d) issue and therefore the Objection cannot be resolved until the outcome of this adversary is determined.

Wherefore, for the foregoing reasons, Montoya requests that this honorable Court overrule the Objection and take whatever further action is proper and just.
