Pursuant to Section 1130.240 (g) of the Illinois Health Facilities and Services Review Board ("HFSRB") rules, I am writing on behalf of Innovia Surgery Center, LLC to notify the Board of a change in the name of Advantage Healthcare, LLC. As you know, on April 28, 2021 the HFSRB Chair approved the restructuring of Advantage Healthcare, Ltd. to an Illinois limited liability company. The Transaction closed effective June 25, 2021. 


