09/08/2021 CONSENT AGREEMENT - License to practice medicine and surgery suspended for a definite period of ninety (90) days, and subject to interim probationary requirements, and a four thousand dollar (\$4,000.00) fine. Based on the doctor's admission that when he diverted medications and controlled substances for self-use, those acts individually and/or collectively constitute the commission of an act that constitutes a felony in this state, regardless of the jurisdiction in which the act was committed, to wit: Deception to Obtain a Dangerous Drug. Agreement effective 9/8/21.
